Independent Accountant's Report on Applying Agreed-Upon Procedures

**To the Board of Directors of
Southern California Gas Company**
San Diego, CA 92101

We have performed the procedures enumerated below related to Southern California Gas Company's ("SoCalGas" or "Company") compliance with the disclosure requirements of subsections (a) and (c) of the California Public Utilities Commission's ("CPUC") General Order No. 77-M ("GO 77-M") for the year ended December 31, 2024. The Company's management is responsible for its compliance with the specified requirements.

The Company's management has agreed to and acknowledged that the procedures performed are appropriate to meet the intended purpose of assisting users in determining whether the Company complied with the GO 77-M requirements 1) that the elements of the 2024 Tables (the 2024 Tables are included in the Company's GO 77-M 2024 Annual Report and consist of the Company's Executive Officers and Employees with a Base Salary of \$250,000 or More Per Annum and Executive Officers of the Utility's Holding Company Summary of Compensation Table, 2024 Options Exercised and Stock Vested Table, 2024 Annual Pension Cost and Above-Market Interest Table, and 2024 All Other Compensation Table) are fully disclosed, clearly described, and comprehensive, and 2) that they are consistent with the books and records of the Company, authorization by the Company's Board of Directors, as applicable, and the documents filed with the Securities and Exchange Commission and other sources available on the internet. This report may not be suitable for any other purpose. The procedures performed may not address all the items of interest to a user of this report and may not meet the needs of all users of this report and, as such, users are responsible for determining whether the procedures performed are appropriate for their purposes.

The procedures performed were not intended to address legal issues as to whether an item is required to be disclosed nor are they designed to address compensation disclosures required by GO 77-M subsections other than subsections (a) and (c).

For purposes of performing these agreed-upon procedures, no exceptions were reported for differences of \$1,000 or less resulting solely from the rounding of amounts disclosed.



The procedures performed in relation to the 2024 Tables and associated findings are as follows:

I. Executive Officers and Employees with a Base Salary of \$250,000 or More per Annum and Executive Officers of the Utility's Holding Company Summary of Compensation Table (Summary of Compensation Table)

Procedures Performed:

A. Column headed "Name" and "Title"

1. We agreed the "Name" and "Title" of the Executive Officers of SoCalGas listed in the Summary of Compensation Table to a report extracted from Sempra's ADP Vantage HCM system identifying employees with a 2024 base salary of \$250,000 or more. For retired officers, we agreed the individual's name to Sempra's ADP Vantage HCM system.
2. We agreed the "Name" and "Title" of the Executive Officers of SoCalGas listed in the respective columns per the Summary of Compensation Table to the "2024 Sempra Annual Report". For non-officers and retired officers not included in the 2024 Sempra Annual Report, we agreed the respective individual's "Name" and "Title" to a report generated from Sempra's ADP Vantage HCM system.
3. We agreed the "Name" and "Title" of the named Executive Officers of Sempra Corporate listed in the respective columns per the Summary of Compensation Table to Sempra's Notice of 2025 Annual Meeting of Shareholders and Proxy Statement as shown below:

No exceptions were noted as a result of performing these procedures.

B. Column headed "Base Salary (\$)"

1. We agreed the dollar amount shown in the "Base Salary (\$)" column for each of the Executive Officers listed in the Summary of Compensation Table to the Compensation History - by EE ID report extracted from Sempra's ADP Vantage HCM system. For retired officers, we agreed the respective individual's base salary listed in the Summary of Compensation Table to Sempra's ADP Vantage HCM system. Amounts reported under the column headed "Base Salary (\$)" did not include payouts of accrued time off balances in connection with retirements and terminations.

No exceptions were noted as a result of performing this procedure.



C. Column headed "Bonus (\$)"

1. We agreed the dollar amount shown in the "Bonus (\$)" column for each of the Executive Officers and Employees listed in the Summary of Compensation Table to the total dollar amount listed within the 2024 bonus report of recognition, discretionary and special bonuses generated from Sempira's ADP Vantage HCM system.

No exceptions were noted as a result of performing this procedure.

D. Column headed "Non-Equity Incentive Plan Compensation (\$)"

1. We agreed the dollar amount shown in the "Non-Equity Incentive Plan Compensation (\$)" column for each of the Executive Officers listed in the Summary of Compensation Table to a report generated from Sempira's ADP Vantage HCM system.

No exceptions were noted as a result of performing this procedure.

E. Column headed "Stock Awards (\$)"

1. We agreed the date and quantity of performance-based and time-based restricted stock units granted in 2024 for each officer and non-officer listed in the respective columns per the Summary of Compensation Table to the Options and Awards Granted report generated from Sempira's E-Trade Equity Edge system.

No exceptions were noted as a result of performing this procedure.

F. Column headed "Annual Pension Cost and Nonqualified Deferred Compensation Earnings (\$)"

1. We agreed the dollar amount shown in the "Annual Pension Cost and Nonqualified Deferred Compensation Earnings (\$)" column for each of the Executive Officers and Employees listed in the Summary of Compensation Table to the total dollar amount in the table titled: Executive Officers and Employees with a Base Salary of \$250,000 or More Per Annum and Executive Officers of the Utility's Holding Company 2024 Annual Pension Cost and Above-Market Interest for the Year Ended December 31, 2024.

No exceptions were noted as a result of performing this procedure.

G. Column headed "All Other Compensation (\$)"

1. We agreed the dollar amount shown in the "All Other Compensation (\$)" column for each of the Executive Officers and Employees listed in the Summary of Compensation Table to the total dollar amount in the table titled: Executive Officers and Employees with a Base Salary of \$250,000 or More Per Annum and Executive Officers of the Utility's Holding Company 2024 All Other Compensation for the Year Ended December 31, 2024.

No exceptions were noted as a result of performing this procedure.



H. Column headed “Allocation”

We did not perform any procedures related to the three columns listed under the “Allocation” column.

II. Executive Officers and Employees with a Base Salary of \$250,000 or More per Annum and Executive Officers of the Utility’s Holding Company 2024 Options Exercised and Stock Vested Table (2024 Options Exercised and Stock Vested Table)

Procedures Performed:

A. Column headed “Option Awards (Service-Based Stock Options)”

1. We agreed the amount shown in the “Number of Shares Acquired on Exercise” column and the dollar amount shown in the “Value Realized on Exercise (\$)” column for each of the Executive Officers and Employees listed in the 2024 Options Exercised and Stock Vested Table to the Confirmation of Exercise report generated from Semptra’s E-Trade Equity Edge system.

No exceptions were noted as a result of performing this procedure.

B. Column headed “Stock Awards (Performance-Based Restricted Stock)”

1. We agreed the amount shown in the “Number of Shares Acquired on Vesting” column and the dollar amount shown in the “Value Realized on Vesting (\$)” column for each of the Executive Officers and Employees listed in the 2024 Options Exercised and Stock Vested Table to the 1) 2024 Awards Released report generated from Semptra’s E-Trade Equity Edge system; and 2) the 2024 Trailing Dividend Calc report prepared by Company management.

No exceptions were noted as a result of performing this procedure.

III. Executive Officers and Employees with a Base Salary of \$250,000 or More per Annum and Executive Officers of the Utility’s Holding Company 2024 Annual Pension Cost and Above-Market Interest Table (2024 Annual Pension Cost and Above-Market Interest Table)

Procedures Performed:

1. We agreed the dollar amount shown in the “Annual Pension Cost (\$)” column for each of the Executive Officers and Employees listed in the 2024 Annual Pension Cost and Above-Market Interest Table to the exhibit prepared by Willis Towers Watson, Semptra’s actuarial consulting firm.

No exceptions were noted as a result of performing this procedure.



B. Column headed "Above-Market Interest (\$)"

1. We agreed the dollar amount shown in the "Above Market Interest (\$)" column for each of the Executive Officers and Employees listed in the 2024 Annual Pension Cost and Above-Market Interest Table who earned above-market interest to the 2024 Excess Interest report prepared by Company management.
2. We agreed the sum of the "Annual Pension Cost (\$)" column and the "Above-Market Interest (\$)" column for each of the Executive Officers and Employees listed in the 2024 Annual Pension Cost and Above-Market Interest Table to the "Total" column per the table.

No exceptions were noted as a result of performing these procedures.

IV. Executive Officers and Employees with a Base Salary of \$250,000 or More per Annum and Executive Officers of the Utility's Holding Company 2024 All Other Compensation Table (2024 All Other Compensation Table)

Procedures Performed:

A. Column headed "Company 401(k) and Related Plan Contributions (\$)"

1. We agreed the dollar amount shown in the "Company 401(k) and Related Plan Contributions (\$)" column for each of the Executive Officers and Employees listed in the 2024 All Other Compensation Table to the totals shown for Match and Excess Match on the 2024 Deferrals reports extracted from Semptra's ADP Vantage HCM system.

No exceptions were noted as a result of performing this procedure.

B. Column headed "Insurance Premiums (\$)"

1. We agreed the dollar amount shown in the "Insurance Premiums (\$)" column for each of the Executive Officers and Employees listed in the 2024 All Other Compensation Table to the dollar amount shown on the 2024 W-2 Summary Report extracted from Semptra's ADP Vantage HCM system for personal liability insurance and executive life insurance unless such benefits were covered under the executive benefit program allowance. For each of the respective individuals, we summed the dollar amounts for executive medical, Medjet, and individual supplemental disability insurance from the Executive Medical Premium Schedule provided by Company management, the Medjet Membership Renewal Report, and the Met Life Supplemental Disability invoice and agreed the resulting total dollar amount to the "Insurance Premiums (\$)" column.

No exceptions were noted as a result of performing this procedure.



C. Column headed “Other Benefits (\$)”

1. We agreed the dollar amount shown in the “Other Benefits (\$)” column for each of the Executive Officers and Employees listed in the 2024 All Other Compensation Table to the total dollar amount shown for financial planning, executive benefit program allowance, and tax gross-ups on the 2024 Exec W-2 Summaries Report extracted from Sempra’s ADP Vantage HCM system. For each of the respective individuals, we summed the dollar amounts for personal use of company cars, drivers and corporate airplane, non-cash gifts, residential security, severance, and charitable matching contributions per schedules prepared by Company management, which shows the list of executives for whom these items are applicable, and agreed the resulting total dollar amount to the “Other Benefits (\$)” column. Amounts reported under the “Other Benefits (\$)” column did not include estimates of costs for benefits provided to retired executives following their retirements or relocation costs for employees who relocated at the Company’s request.

No exceptions were noted as a result of performing this procedure.

D. Column headed “Health & Welfare Benefits (\$)”

1. We agreed the dollar amount shown in the “Health & Welfare Benefits (\$)” column for each of the Executive Officers and Employees listed in the 2024 All Other Compensation Table to the dollar amount shown for the Company’s flexible benefits contributions on the 2024_Co_Cost_for_Benefits_for_GO-77_Filing report extracted from Sempra’s ADP Vantage HCM system.

No exceptions were noted as a result of performing this procedure.

V. 2024 Tables

Procedures Performed:

We recalculated the mathematical accuracy of the following tables:

- A. Summary of Compensation Table, except for the three columns listed under the “Allocation” column, for which we did not perform any procedures.
- B. 2024 Options Exercised and Stock Vested Table.
- C. 2024 Annual Pension Cost and Above-Market Interest Table.
- D. 2024 All Other Compensation Table.

No exceptions were noted as a result of performing these procedures.



We were engaged by the Company's management to perform this agreed-upon procedures engagement and conducted our engagement in accordance with attestation standards established by the American Institute of Certified Public Accountants. We were not engaged to and did not conduct an examination or review engagement, the objective of which would be the expression of an opinion or conclusion, respectively, on compliance of the 2024 Tables with subsections (a) and (c) of the CPUC's GO 77-M. Accordingly, we do not express such an opinion or conclusion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

We are required to be independent of the Company and to meet other ethical responsibilities in accordance with relevant ethical requirements related to our agreed-upon procedures engagement.

This report is intended solely for the information and use of the Audit Committee of Sempra, Board of Directors and management of SoCalGas, and the CPUC and is not intended to be, and should not be, used by anyone other than these specified parties.

This narrative statement and the amounts reported herein generally follow the presentation included in the Sempra proxy statement and Southern California Gas Company (SoCalGas or the company) information statement prepared for their annual meetings of shareholders held on May 13, 2025 and June 5, 2025, respectively.

1. Base Salaries

SoCalGas' executive compensation program emphasizes performance-based pay. This includes annual cash bonuses and long-term equity-based incentives. However, base salaries remain a common and necessary element of compensation for attracting and retaining outstanding employees at all levels.

Base salaries for officers are reviewed annually and the following factors, among others, are considered:

- Market salary data from multiple surveys
- Individual contribution and performance
- Labor market conditions
- Complexity of roles and responsibilities
- Succession planning
- Retention needs
- Reporting relationships
- Internal pay equity
- Experience

Base salaries also may be reviewed and adjusted during the year (between annual reviews) for various reasons, including in the event of promotions or other job title changes, modifications to reporting relationships or job functions, or changes to any of the other factors described above or other circumstances considered relevant.

2. Performance-Based Annual Bonuses

Each year the SoCalGas Board of Directors establishes performance measures and dollar guidelines for performance-based cash bonus payments under the SoCalGas Executive Incentive Compensation Plan. The safety measures and measures related to safety management systems are also reviewed by the board's Safety Committee. Consistent with our pay-for-performance philosophy, the performance measures do not provide for any bonus payment unless the company meets the threshold (minimum) performance level for the year. Bonus opportunities increase from 14% of target for performance at the threshold level to 200% of target for performance at the maximum level. For a detailed description of individual bonus opportunities, performance measures and 2024 results, please refer to pages 51-55 and 102-104 of the Sempra proxy statement and pages 15-18 of the SoCalGas information statement.

Potential bonus opportunities at threshold, target and maximum company performance are expressed as a percentage of each officer's base salary. Extraordinary company or individual performance may result in the payment of bonuses above the guidelines.

3. Long-Term Equity-Based Incentives

Long-term equity-based incentives are a large component of each officer's target total direct compensation package. In 2024, the long-term incentive plan award was in the form of performance-based and time-based Sempra restricted stock units. This equity award structure was approved after considering many variables, including alignment with shareholder interests, retention, plan expense, share usage, market trends and feedback from Sempra's shareholder engagement.

Performance-based restricted stock units:

Each annual performance-based restricted stock unit granted in 2024 represents the right to receive between zero and 2.0 shares of Sempra common stock. The 2024 annual performance-based

restricted stock unit awards are based on two performance measures – relative total shareholder return and earnings per share growth.

Time-based restricted stock units:

Time-based restricted stock units granted in 2024 vest in equal installments of one-third over a 3-year period, subject to continued employment through each vesting date. The primary purpose of these awards is to promote retention.

Benefit Plans

Officers also participate in other benefit programs including: 1) Health, Life Insurance and Disability Plans, and Other Benefits; 2) Retirement Plans; and 3) Savings and Deferred Compensation Plans. These benefits are described on pages 59-61 of the Sempra proxy statement and pages 22-24 of the SoCalGas Information Statement.

Regular Employee Benefits

The SEC's proxy rules, for the most part, do not require reporting of broad-based employee benefit plans such as those providing medical, dental, life or disability coverage. However, amounts related to broad-based pension benefits and the 401(k) savings plan are discussed in the Compensation Discussion and Analysis and reported in the executive compensation tables.

The companies' flexible benefits plan allows employees to select the types and levels of benefits that best meet their needs and those of their families. Benefit options include:

- Medical plans (choice of HMO's and a high-deductible health plan)
- Dental plans (choice of Delta Dental plan and dental HMO)
- Long-term disability coverage
- Life insurance
- Accident insurance
- Healthcare, dependent day care and transportation flexible spending accounts

Each benefit option has a price tag reflecting the employee's cost for coverage. The amounts shown in the All Other Compensation table in this report reflect the portion of the benefit costs paid by the company.

In addition to the flexible benefit plan, the company also provides short-term counseling and referral services under the employee assistance plans and various wellness programs.

SOCALGAS COMPANY PROPORTION OF COMPENSATION PAID DIRECTLY OR INDIRECTLY BY UTILITY CUSTOMERS FOR THE YEAR ENDED DECEMBER 31, 2024

In the Test Year (TY) 2024 General Rate Cases (GRC), Southern California Gas Company (SoCalGas) did not seek recovery of all compensation. Consistent with P.U. Code Section 706 and Resolution E-4963, SoCalGas did not seek recovery of forecasted compensation and benefits costs for SoCalGas' officers in the TY 2024 GRC. In addition, SoCalGas voluntarily excluded forecasted Long-Term Incentive Plan (LTIP) costs for all eligible employees and forecasted compensation and benefits costs for Sempra SEC Rule 240.3b-7 officers.

For employees of SoCalGas who are not Resolution E-4963 officers, in Decision (D.) 24-12-074, the California Public Utilities Commission resolved Southern California Gas Company's (SoCalGas') 2024 General Rate Case ("2024 GRC"), authorizing SoCalGas to recover the costs set forth below.

- **Base Salaries:** the costs for SoCalGas employee base salaries, except as expressly noted in D.24-12-074;
- **Spot Cash and Employee Recognition ("Bonus" column in schedule):** the costs for SoCalGas employee spot cash and employee recognition;
- **ICP/Variable Pay (Non-Equity Incentive Plan Compensation column in schedule):**
 - 31% of the forecast costs for SoCalGas Executive ICP;
 - 41% of the forecast costs for SoCalGas Non-Executive ICP;
- **Pension:**
 - The costs for SoCalGas' qualified pension plan;
 - 43% of the forecast costs for SoCalGas' nonqualified pension and nonqualified savings plan;
- **All Other Compensation:**
 - the costs for SoCalGas' qualified 401(k) retirement savings plan;
 - none of the costs for certain other executive benefits, such as financial planning, which were not requested in the 2024 GRC; and
 - a portion of the forecast costs for health and welfare benefits for employees.
