Your Honors directed SoCalGas to provide an update, by Thursday, May 13, as to the status of SoCalGas' subpoena for the appearance of the Boots & Coots witnesses by. SoCalGas learned this morning that Boots & Coots will be moving for a protective order to relieve Dr. Haghshenas and Mr. Walzel of any obligation to comply with the Commission subpoenas. Once the Motion for Protection is filed, SoCalGas will file a response and request a hearing date to seek to compel the appearance. It is unlikely that any hearing on the subpoena will occur prior to next week's scheduled evidentiary hearing dates. As such, and as discussed on Monday, SoCalGas proposes that Mr. Schwecke's examination proceed on May 18-20.
